8. OLD BUSINESS

8.1 Project No. N-SUP2023-00013 - Mittry Farms LLC.

Brief update about Board of Supervisors meeting scheduled for Sept 24. SLO Planning Commission (3 to 1) has recommended approval to change the zoning from commercial to residential, contrary to TAAG's recommendation.

PUBLIC COMMENT: TAAG report is excellent.

PUBLIC COMMENT: TAAG recommendation to Planning Commission had an oversight. There was no mention of traffic circulation study. TAAG needs a more concise letter with numbered issues.

PUBLIC COMMENT: A realtor commented that selling would be difficult with all the ADUs.

8.2.1 Project No. N-DRC2024-00026 - Mavrik Inc. Fueling Station Facility Application withdrawn.

8.2.2 Project No. N-DRC2024-00022 - AU Energy LLC Gas Station Facility;

Their presentation to the TAAG Board has been rescheduled our next TAAG Board meeting 8/15/2024.

PUBLIC COMMENT: California cities are banning the establishment of new gas stations.

PUBLIC COMMENT: Suggests low-traffic commercial retail development.

8.3 N-SUB2024-00024 TVJ LLC

TVJ LLC will attend next TAAG meeting in August.

9. NEW BUSINESS

9.1 Dirk Winter Hotel Project

C.J. Horstman made a ~35 minute slide presentation outlining the scope of the project and rendered pictures of the finished project. It would be a 60 room hotel, no more than 2 stories in height, with designated guest parking inside the complex. There would be several outdoor fire pits, and a raised old style water tank on the Main Street side of the project. Each building would have a different façade; wood, sheet metal, and brick. (One building would replicate the Templeton Feed building.) There would not be any bars, retail stores, nor restaurants, other than a small 'restaurant' that would offer breakfast to their quests.

PUBLIC QUESTION: Water units?

ANSWER: 8 water units. They have drilled a well, hit riparian water. Working with TCSD to get meters for riparian rights. They hit basin water, which is proposed for irrigation.

PUBLIC QUESTION: Will there be any long-term units?

ANSWER: 6 suites may be used for longer stays.

PUBLIC QUESTION: Kitchens and laundry?

ANSWER: no kitchens. all laundry off-site due to water restrictions.

EDWARD BIK: How many employees are in the plan?

ANSWER: 12-13 total.

PUBLIC QUESTION: Has a traffic study been done? Could speed limit be

reduced on North Main St?

ANSWER: That is an issue for Public Works.

PUBLIC: The Sheriff may help with speed reduction request.

9.2 N-SUB 2024-00045. Knabenshue

Applicant's father Bruce Knabenshue presented the project.

No objections or concerns were expressed.

There was a discussion amongst the Board members as to what we state in our communication when giving our approval to the SLO Planning Department. The Board voted and approved using the following words;

"TAAG has reviewed Project _____ and approves (supports*) it with no concerns."

*Perhaps support is more appropriate as we can only make recommendations.
