Meeting on Thursday May 20th was held by telecommunication / zoom video call

1. CALL TO ORDER - Meeting was called to order at 5:30 p.m. by Bruce Jones.

2. ROLL CALL - Bruce Jones, Murray Powell, Erik Gorham, Dede Davis, Doris Diel, Don Potts.

3. AGENCY REPORTS AND UPDATES

- **3.1. Sheriff's Office** - This month the department received 1,674 calls for service, 368 of which were from Templeton. There were; 4 calls for assault and battery, 16 disturbance calls, 1 burglary, 3 thefts, 4 vandalism calls, 6 trespassing calls, 24 calls suspicious circumstances.
- **3.2. California Highway Patrol** - CHP has investigated 25 crashes, 4 collisions were DUI related. This year there have been 15 DUI related collisions. None of which were fatal. 9 DUI related arrests in this area. CHP wants to remind the public to not drink and drive.
- **3.3. Supervisorial District One** - District One informed us that we will be hearing from Governor Newsom on updating COVID restrictions and getting businesses and park functions back open and running. On June 8th the board will meet to discuss the hydro-geologic study and discuss recommendations on further direction for that study. On June 14 - 16 there will be budget hearings taking place. On June 28th there will be a redistricting update, and lastly on June 22nd there will be a meeting regarding cannabis project update.
- **3.4. Supervisorial District Five** - Not Present.
- **3.5. County Planning Department** - No Updates.
- **3.6. Templeton Community Services District** - TCSD wants to remind the public to keep their yards maintained entering wildfire season. Templeton is working on getting community events up and running again but they are working within state guidelines, and are waiting to hear from the Governor on updating COVID restrictions.

- **7.1 - DRC2021-00102—FILLIPONI** The PRC reviewed the application for this project at their May 6, 2021 zoom meeting. This project is a Minor Use Permit to

allow a quick-service restaurant with a drive-through and a gas station with convenience store, including an attached single car-wash tunnel, and eight fuel dispensers, located in Templeton on an approximately 2-acre parcel at the northeast corner of Las Tablas Road between Bennett Way and Duncan Road. The May 6, 2021 PRC meeting report is available on the TAAG website (<http://www.taaginfo.org>) under "Reports." The Delegates of the PRC voted unanimously to defer making a recommendation regarding this project until later when the project application is in its final form. Several members of the community made comments expressing concern about this project.

Motion - TAAG voted unanimously to defer the project until more information is received.

This issue arose as a result of the project addressed in agenda item 7.1 above.
